Newsletters are distributed to approximately 20,000 individuals on our mailing list - people who are currently or formerly incarcerated and their families, and those who work in the prison system. In addition, every year the foundation receives and responds individually to thousands of letters from those incarcerated, their families, workers and the general public.

4b (Code:) (Expenses \$ 124,689. including grants of \$ 1,569.) (Revenue \$ 7,038.)

We create, curate, print, and distribute books on spirituality, mindfulness, and wellness to people experiencing incarceration and their families. This includes working with writers and authors who have experienced incarceration to create and publish new works. These resources are sent at no charge in response to requests received from people who are incarcerated, their families, and those working in prisons. In 2024, we distributed 10,600 books free of charge.

We distribute books, newsletters, videos, and podcasts on the free educational app, Edovo, available at over a 1000 prisons and jails across the country. We have 72 resources available on this app. These resources have been accessed over 50,000 times.
